- As you may know, I am fortunate to win one of the five endorsements of the RTC to represent District 5 (Riverside) in the Town's Republican Town Party. - When reviewing the signatures, I was very surprised to see your name. The signatures were collected over a three-day period during the last week of January. I would very much appreciate your confirmation whether or not you were in town and signed the petition.
